Membership Requirements and Categories

Membership is automatic in UMAPP with an existing ASI or PPAI number (SAGE numbers are considered on a case-by-case basis). Multiline reps do not need an ASI, PPAI, or SAGE number to qualify for membership, and do not need to be a UMAPP member to exhibit at the Booth Show (but all of the lines exhibited do need to be members).

If no ASI, PPAI, or SAGE number:

- Submit 10 purchase orders (suppliers) from 10 different industry distributor companies.
- Submit 10 invoices (distributors) from 10 different industry supplier companies.
- Submit either 10 invoices or purchase orders, or 10 written references (business services members) from industry suppliers or distributors, and have been selling services to this industry for at least one year.

Membership Categories (check one):

- Distributor Member. A company whose primary business includes developing ideas for the use of promotional products, buying such products from suppliers (manufacturers) and reselling them to end-buyers.
- Supplier. A supplier is a company that manufactures, converts, warehouses, or decorates promotional products for sale to promotional products distributors or to a firm maintaining a division or affiliate devoted to reselling promotional products.
- Business Services Member. Company that is not in the promotional products industry, but sells services (such as fulfillment) to both suppliers and distributors.
- Multi Line Rep. An independent company, contracted by one or more suppliers to market their products and services to distributors.

Dues and Payment

Annual dues (January – December): \$110 when corporate office is in the five-state area of MN, ND, SD, IA, WI; \$95.00 when corporate office is in all other states. *Dues are based on a calendar year; if joining between June and December, contact the UMAPP office for the pro-rated dues amount.* UMAPP accepts Visa, MasterCard, American Express, or checks.
